Also, the undersigned understands that these risks and hazards can possibly lead to severe injuries from the animals at Oliver and Friends Farm Rescue and Sanctuary (hereinafter referred to as "Sanctuary") as well as risks associated with manual labor at the Sanctuary.

The Undersigned, wishes to proceed and freely accepts and expressly assumes all liability of risk, danger, and hazards that may arise from volunteering at the Sanctuary, which could result in personal injury, loss of life, and property damage.

The Undersigned, for himself/herself, and personal representatives, assigns, heirs and next of kin, or any of them, hereby Covenants Not To Sue and Releases, Waives, Discharges, **Oliver and Friends Farm Rescue and Sanctuary**, and its owner, board of directors, employees, volunteers, and each of them, (for all purposes herein referred to as Releasees), from ALL liability to the Undersigned, their personal representatives, assigns, heirs and next of kin for all loss or damage and any claims or demands therefore, on account of injury to the Undersigned, whether caused by the negligence of Releasees or otherwise while the Undersigned is on the grounds of **Oliver and Friends Farm Rescue and Sanctuary**.

The Undersigned acknowledges that no oral representations, statements or inducements apart from the foregoing written Waiver and Release have been made and that this Waiver and Release shall be governed by and interpreted in accordance with the laws of the State of Oklahoma.

The Undersigned agrees that if any provision of this Waiver and Release is found to be unenforceable or invalid, that provision shall be severed from this Waiver and Release and the remainder of this Waiver and Release will then be construed as though the unenforceable provision had never been contained in this Waiver and Release.

The Undersigned declares that he/she is of legal age (18 years of age or older) and is competent to sign this Waiver and Release.
